SUBJ: Request for Award of Proposal #1702 FENCING SUPPLIES & INSTALLATION

This proposal was established to qualify approved vendors under the State Purchasing Guidelines CH Legal and Education Code 44.031(a) whereby school districts are required to utilize a competitive bidding method that provides the best value for the district when making purchases valued at \$50,000 or more in **the aggregate** for a 12 month period. To satisfy State Law, end user requests and based on prior year's usage, Alvin ISD extended this proposal. Thirteen vendor information packets were emailed and sent to various vendors via Ion Wave. The proposal documents were also made available on the Alvin ISD Website. Seven responses were received. This proposal covers the following commodity categories & sub-categories:
